

Letter dated 13 November 2008 from the Permanent Representative of the Sudan to the United Nations addressed to the President of the Security Council

Please find attached the five decisions issued by the Sudanese Minister of Justice in connection with the legal process concerning Darfur as follows:

- 1. The appointment of the Special Prosecutor to investigate the alleged crimes committed in Darfur (annex I).
- 2. The establishment of the Committee of the Wise in South Darfur State (annex II).
- 3. The establishment of the Committee of the Wise in North Darfur State (annex III).
- 4. The establishment of the Committee of the Wise in West Darfur State (annex IV).
- 5. The establishment of the High-level National Committee to assist the Special Prosecutor (annex V).

I should be grateful if the present letter and its annexes were issued as a document of the Security Council.

Decision of the Minister of Justice appointing a Special Prosecutor for the crimes committed in Darfur

Pursuant to the provisions of article 6 of the regulations of the Ministry of Justice of 1983 the following decision is promulgated:

1. Name and entry into force of the decision.

The decision shall be known as the "Decision appointing the Special Prosecutor for the crimes committed in Darfur"; it shall enter into force on the date of its signature.

- 2. Nimr Ibrahim Muhammad, General Counsel, is hereby appointed as Special Prosecutor for the crimes committed in Darfur during the period from 2003 onwards. He shall be assisted by a Committee comprising the following persons:
 - (a) Kamal Mahjub Ahmad, Senior Counsel
 - (b) Hadi Mahjub Makkawi, Senior Counsel
 - (c) Ma'mun Maki Hamid, Senior Counsel
- 3. The Special Prosecutor for the crimes in Darfur may seek assistance from whoever he deems appropriate.
- 4. The Special Prosecutor for the crimes in Darfur and his assistants shall investigate the crimes committed in Darfur and shall bring prosecutions in respect of them before the courts.
- 5. The Special Prosecutor for the crimes in Darfur shall submit a detailed report to the Prosecutor General of the Republic of the Sudan every month setting forth the status of the cases, the proceedings and the action taken.

- (c) Coordinating with the Committees of the Wise in the Darfur States with a view to attaining the objectives and meeting the needs of those Committees and ensuring good cooperation between them.
