<u>DECLARATION ON THE SITUATION IN</u> THE CENTRAL AFRICAN REPUBLIC (CAR)

- 1. The Peace and Security Council (PSC) of the African Union (AU), at its open briefing session, held on 30. March 2006, noted the remarks made by the Commissioner for Peace and Security and the Special Envoy of the Chairperson of the Commission for CAR on the evolution of situation in the CAR, and received statements. from the Representative of the Government of the Central African Republic, of the Office of the United Nations in the Central African Republic (BONUCA), the Representative of the Secretariat of Economic and Monetary Community of Central Africa (CEMAC) and the Command of the Multinational Force of CEMAC (FOMUC);
- 2. Council **notes** with **deep** concern 'the situation of insecurity in the north of the CAR and the serious consequences on the political situation in the country and on the life of the population in that part of the country, with several thousands of people already having left their settlements to seek refuge in the south of Chad;
- 3. Council **notes**, **also**, the efforts deployed **by** the Government of the Central African Republic to maintain security in Bangui and to promote security on the rest of the national territory;
- **4.** Council **expresses** Its appreciation **of** the continued support of the BONUCA to the Government of the Central African Republic and the efforts of the United Nations agencies aimed at the stabilization of the CAR, the strengthening of its capacities to deal with the situation, **as** well as the improvement of the living conditions of refugees and internally displaced persons;
- 5. Council underlines the obstacles facing the Government of the Central African Republic in its efforts to redress the socio-economic and security situation, obstacles that are a particular result of insufficient financial resources and inadequate international assistance;
- 6. Council further notes, **with** satisfaction, the multifaceted efforts deployed by CEMAC to bring about the stabilization **and** revitalization of the economy in the CAR and **appreciates**, in particular, the activities of FOMUC on the ground. In this **regard**, **Council** welcomes the cooperation between the AU, the European Union (EU) and the CEMAC, which has enabled the FOMUC to carry out its mission in the CAR. Council calls on the Commission of the African Union, the Central African Government, the BONUCA and the CEMAC to work together to find a lasting solution to the **problem** of the CAR;

- 7. Council **welcomes** the decision of the Chairperson of the Commission to dispatch a multidisciplinary mission of **experts** to the CAR to evaluate its needs and to make appropriate recommendations on the **assistance** that **Member** States and **the** AU could provide to the CAR, within **a** holistic programme of post-conflict reconstruction;
- 8. Council **reiterates** its appeal, as contained in **the Communiqué** PSC/PR/Comm. (XLIV) of the 44th Meeting of the PSC, **held on** 29 December 2005, **to AU Member States**, bilateral and multilateral partners **of** the CAR, **to** provide **support** towards the implementation of the recommendations of the **experts** and **continue to** provide the urgently needed aid for the reconstruction in the CAR,
